

**YMCA Camp Ockanickon Inc.

YMCA Camp Ockanickon, Inc. requires that parents provide a list of authorized persons who may pick-up their child from the Lake Stockwell Day Camp Program. The names of authorized persons must be on file with the Camp's Business Office prior to your child's attendance. Only authorized persons will be permitted to pick-up children from the camp or the bus stops. **Parents - please do not forget to list yourself on this form.** When someone on your authorization form will be picking up your child, a note to the Program Director is helpful in expediting the pick-up process. Additions may be made during the child's session by completing an additional form.

**We WILL NOT release campers to an individual not authorized to pick up the camper.
We WILL NOT drop off campers at a bus stop if there is no one there to meet them,
or if the individual waiting there is not authorized to pick up the camper.**

BEHAVIOR MANAGEMENT FORM

Please read this form carefully and then go over the rules and consequences with your child. Once both you and your child have read it, please sign the bottom and have your child sign it as well.

In order for all campers to have the best possible experience, all campers need to be aware of the rules and agree to follow them. If a camper consistently or excessively breaks the rules and chooses not to take part in camp, they negatively affect other campers by jeopardizing their physical or emotional safety. When this happens all other campers in that village fail to receive the best possible camp experience. In the event that a camper chooses not participate in camp we will encourage them to do so by following the rules and respecting others. At that time a phone call will be made to the parents to enlist their help in resolving the situation. If the camper still chooses to consistently or excessively break the camp rules, the parents will be asked to come and pick up the camper. If a camper is sent home for failure to comply with the camp rules, no refund will be given.

Camp Rules:

- To treat myself, others, and camp with Caring, Honesty, Respect, and Responsibility.
- To follow direction and instructions from staff.
- To keep hands, feet and all other body parts to myself.
- To respect all camp facilities, equipment, and property.
- To have FUN!

Camper Consequences:

- Redirection of camper
- Verbal warning or time out
- Visit camp director and call home. Child will speak to parents at that time.
- In the event that a second phone call is necessary, the child will be sent home.

In the event of consistent or excessive failure to follow the rules the camper will be sent home. If the camper severely endangers the physical, mental or emotional health of another individual, the camper may be sent home immediately.
